And everything that we do at Kindred Lutheran is focused on this faith formation process. It is our way of helping one another become the disciple Jesus is calling us to be. 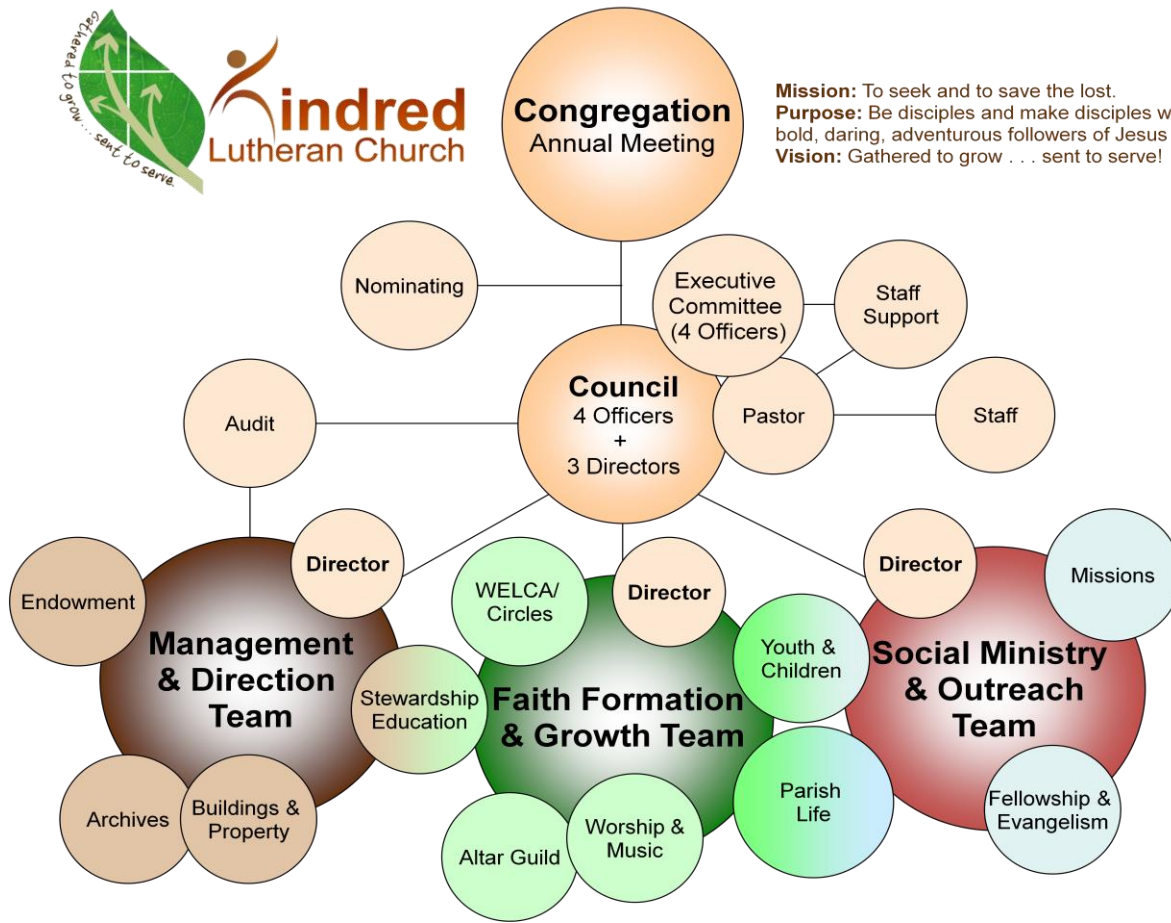

2010 ANNUAL MEETING MINUTES

Kindred Lutheran Church Annual Meeting
January 17, 2010
Unofficial Minutes

The annual meeting of Kindred Lutheran Church was called to order by President Rodney Braaten.

All shared in the devotions printed in the annual report.

SECRETARY'S REPORT: Secretary Dona Schock read the 2009 Annual Meeting Minutes to the congregation. A motion was made and seconded to approve the January 18, 2009 annual meeting minutes. Motion carried. Secretary Dona Schock read the May 31, 2009 Special Congregational Meeting Minutes to the congregation. A motion was made and seconded to approve the minutes as presented. Motion carried.

PRESIDENT'S REPORT: Rodney took this time to thank Kelly Perhus and Julie Otterson for their help during the year.

TREASURER'S REPORT: Treasurer Lynette Girodat stated that the balance on hand as of the end of 2009 was \$35,050.94. A motion was made and seconded to approve the Treasurer's Report as presented. Motion carried.

ACCEPTANCE OF PRINTED REPORTS: A motion was made and seconded to approve the reports printed in the annual report. Motion carried.

PRESENTATION OF THE 2010 BUDGET: A motion was made and seconded to approve the 2010 budget as presented. Motion carried.

OLD BUSINESS:

COUNCIL RESTRUCTURING: Kitty Blilie reported on proposed changes to the constitution and restructuring of the council and leadership. This will be the first vote and a second one is required at the next annual meeting in 2011. A motion was made and seconded to accept the Restructuring Committee Report as presented. Motion carried. The constitutional changes were approved unanimously.

NEW BUSINESS: No new business was presented.

NOMINATING COMMITTEE REPORT: The new slate was presented for the candidates as nominated for office. Rodney Braaten as President; Christine Ilvedson as Vice President; Dona Schock as Secretary; Wes Robertsdahl as Financial Secretary; Janet Kub as Worship Committee chair; Kitty Blilie as Compassion Committee chair; Velora Robertsdahl as Parish Life Committee chair; Gene Thompson as Grounds/Property Committee chair; Teresa Braaten as Youth & Children's Ministry chair; Sally Erickson as Stewardship Committee chair. The position of treasurer is open because Treasurer Lynette Girodat has fulfilled her maximum of 3 years term. She has agreed to stay on as treasurer until a replacement has been found. WELCA is also open.

A motion was made and seconded to accept the Nominating Committee Report as presented. Motion carried.

Motion to adjourn was made and seconded. Motion carried.

PASTOR'S REPORT



The Word: God's Story. Our Story.

Dear Brothers and Sisters in Christ,

It's all about Jesus. That's right. It's not about me or you. Sometimes that's not easy to remember in our hectic lives. Our Christian life is lived out in response to Jesus' invitation: "Follow me" (Matthew 4:19). Discipleship is a lifelong calling to repent, believe, connect, rest, pray, dwell in the Word, worship, serve and give. Jesus calls us to be disciples and make disciples (Matthew 28:18-20).

Central to our identity as disciples is the Bible—the story of God acting in human history. When we dwell in God's Word, we become more aware of where God is and what he is up to. We learn to recognize his voice. We learn to see his presence. We learn how we fit into God's story. We see how God has acted and moved in our lives, so we can share our own compelling story of his grace and be more fully engaged in the life and mission of God for the sake of the world.

The Word: E100

Since September 2010, we have been engaged in reading through 100 of the essential stories of the Bible as a congregation, including adults, confirmands and Sunday school students called "E100: God's story. Our story." We read five passages from the Bible each week for 20 weeks. Weekly sermons are based on the E100 readings. They are also being used in the Adult Bible Study led by Marlys Bergene and Craig Hertsgaard. I have not only been reading along with you, but have also been modeling it by blogging about the daily readings at blog.kindredlutheran.com. I have made tools for Biblical fluency available on our web site www.kindredlutheran.com, through our weekly email called "eConnections", as well as Facebook and Twitter.

The Word: Council

What is the business of the church? Making disciples. Being disciples. Witnessing to the life, death, and resurrection of Jesus. Thus leadership in a church is spiritual. This is particularly true of the council. As pastor, I encourage the council to imagine God's preferred future by being engaged in Scripture, prayer, silence and listening.

Thus, Council meetings typically begin with 20-30 minutes of engagement with Scripture. We read a passage from the Bible (sometimes more than once) and sit in silence for a minute as we dwell in God's Word, often focusing on simple questions.

Council members then share in small groups of 2-3 people what they have heard. As we gather together as a large group, members are often invited to take turns sharing what their partner shared with them—not what we shared with them! The purpose is to learn listening skills—we learn to listen to one another as well as listen to God's Word. We also learn that to be a People of the Word means we dwell in Scripture and struggle with its meaning as a community not just as individuals.

The Word: Living Stones

During Lent 2010, we engaged in Bible reading as a congregation. Our theme was "Living Stones!" I taught all the children one Sunday morning to encourage Bible reading, prayer and family discussions.

The children brought home a paper bag they decorated for Lent. Inside of each bag were 5 stones. On each stone the children had written a word—share, read, talk, pray, bless. Everyone was invited to gather as a family for 15 minutes one night each week for the 7 weeks of Lent and try this Lenten discipline. Bookmarks with the instructions on them were included in the bags, distributed during worship, included in the newsletter, in *eConnections* and posted on the website. A children's sermon explained the Lenten discipline to the whole congregation who was invited to participate as well.

The Word: Worship

In 2010, we quit using the lectionary inserts in the bulletins and purchased Bibles for the pews so people could actively use the Bibles during worship. The inserts cheapened God's Word—we tossed them in the garbage! Our children did not understand that the readings on Sunday morning actually came from the Bible. The bulletin inserts made people less familiar with Scripture, decreased their confidence in daily Bible use and caused them to look to the pastor as the only expert in interpreting Scripture. In short, the less we used our Bibles in church, the less we used them at home. We had become biblically illiterate.

The council was so excited about this proposal that they purchased over twice as many Bibles as I asked them to buy! I am intentionally encouraging worshipers to use Bibles during worship, even having you join in reading aloud portions of the Scripture, and not just the Psalms.

We are exploring the possibility of putting notices in the bulletins inviting people who need a Bible to take one. We are even considering hanging a ship's bell in the back of the church with the following notice: "Ring this bell so we can celebrate! If you do not have a Bible, or if you know of someone who needs a Bible, please take one of the pew Bibles with you and ring this bell! Take it, use it, and dwell in God's Word as a gift from us in Jesus' name!" We have already had two people ask for permission to take a Bible from church. Praise the Lord!

The Word: Biblical Fluency

Kindred Lutheran Church has been chosen by Luther Seminary as one of only a handful of congregations in the country to participate in their Biblical Fluency Project! Over the next 18 months, we will work with Luther and the other congregations to form a learning community dedicated to understanding the link between Biblical fluency and congregational vitality. This learning is centered on a five-to-seven member action reflection team co-chaired by Craig Hertsgaard and myself. I hope that you will find this work to be engaging, inspiring, and spiritually nourishing.

Participation will be a great way to reinforce our sense of identity and calling as people of God. It will help us to learn how to listen. It will transform our Christian imagination. It will help us create a balanced and healthy congregation where we grow disciples of Jesus and not simply grow a church

The Word: 125th Anniversary

One of my hopes is that the theme "God's story. Our story." will lead right into the celebration of our 125th anniversary in 2012 so that the focus will be on God and where he is leading Kindred Lutheran Church. The best place to begin this discernment process is in Scripture. Too often, congregational anniversaries focus inward. Participation in the Biblical Fluency Project with Luther Seminary offers the opportunity to help us think outside of ourselves by encouraging us to dwell in Scripture, to listen and to imagine God's preferred future. It will help us gain a sense of our missional vocation both as individuals and as a congregation. Together we will ask questions: What is God up to? What is God calling us to do? What is God up to in the community around us? Who is God calling us to be? What are God's promises? How do we respond?

Final Thoughts

You don't go *to* church. You *are* the church. Discipleship is who you are and what you do "out there" in the world not just inside a church building. It's the way you live, work, learn and play. It's the way you love, care, serve and give. And you do it well!

Thanks for being the church! Thanks for the generosity and encouragement you show to me, my family and our community. I am so blessed to be here at Kindred Lutheran Church...to serve as your pastor...to walk with you on this journey...to work beside you for the sake of the world!

I can't wait to see where Jesus will lead us this year. And how the Holy Spirit will make us grow as we experience life together and Dwell in God's Word!

MISSIONS

Our goal is to continually encourage service and participation from the congregation and community, in ongoing current, and future, outreach concerns. Local, regional, and national, as well as international needs, present several ways for us to answer our call to service for others. During the spring flooding, we contacted the City of Kindred and offered to assist with concerns involving possible assistance needs of residents, as well as encouraging all to be of service to others that were in need themselves. This is one of our goals through the People To People task group. Not only during times of crisis or hardship, but also for day-to-day issues.

The “Ultimate Gift” was a project undertaken by the youth in which they were to give away everything that could take in and keep nothing for themselves. We actively participated with them, in that we provided the sum of \$50 to each participant, as startup funding. It was their task to grow that amount, by using their gifts and talents, and then at the end to give it all away! Through this project, the youth were able to experience being good stewards of God’s gifts to them.

Also this year, there was a request made by the Women’s Shelter for emergency placement of an individual family to a hotel, as their shelter was filled to capacity. We gladly supported this request for assistance, and were thankful we were able to assist with that need, through their organization. They serve a very important and compassionate role in the community and surrounding area.

Other projects and plans we have also been involved with would include Lenten Service meals; holiday food baskets; community days preparation; and reviewing and gathering information regarding future mission efforts. And our committee will be submitting suggestions to the church council for designating the benevolence offerings that our congregation collects through the year in the weekly offerings, which are not individually designated.

We look forward to exploring more ways to help all of us always look for, and live our lives, in service to others.
